National Conference on Sex Offender Registries - 1998

This document presents the proceedings of the conference. Day One of the conference focused primarily on the sex offender problem from a Federal perspective. A panel of U.S. Justice Department officials discussed various aspects of the Federal statutes and conducted an informative question-and-answer session to address the specific concerns of individual States. Day Two began with a presentation by FBI representatives concerning preparations the Bureau is taking to assume control of registration and notification functions in States unable to establish their own effective programs.

Sex Offender Registration - Garrine P. Laney 2009

This book provides a side-by-side analysis of various sex offender-related provisions in the "Children's Safety and Violent Crime Reduction Act of 2006" (H.R. 4472), the "Children's Safety Act of 2005" (H.R. 3132), and the "Jacob Wetterling, Megan Nicole Kanka, and Pam Lychner Sex Offender Registration and Notification Grant Act" (S. 1086). The House passed H.R. 4472 and H.R. 3132 on March 8, 2006 and September 14, 2005, respectively; the Senate passed S. 1086 on May 4, 2006. Among others, provisions analyzed in this memorandum include: registration requirements for sex offenders; registration requirements for jurisdictions; monitoring of sex offenders; national sex offender public website; national sex offender registry; address verification procedures; community notification; and studies and reports on effectiveness of programs.

Sex Offender Registration and Community Notification Laws - Wayne Logan 2021-06-17

This volume is the first comprehensive empirical examination of the premises and effects of sex offender registration and notification laws.

Sex Offender Registration and Notification Act - Randall B. Harris 2013

Sex offences are fairly common in the United States and largely go unrecognised and

underreported. Studies estimate that about 1 in every 5 girls and 1 in every 7 to 10 boys are sexually abused by the time they reach adulthood, and about 1 in 6 adult women and 1 in 33 adult men experience an attempted or completed sexual assault. In the wake of several tragic attacks in 2005 in which young children were kidnapped, sexually assaulted, and murdered, public and congressional attention became increasingly focused on what was described as the growing epidemic of sexual violence against children. Citing a need to address loopholes and deficiencies in individual state registration programs that made it possible for convicted sex offenders to move from one jurisdiction to another and evade registration, in 2006, Congress passed and the President signed the Sex Offender Registration and Notification Act (SORNA). This book address to what extent SORNA has been implemented and what challenges jurisdictions face; and its effect on public safety, criminal justice stakeholders, and registered offenders.

Policing Sexual Offences and Sex Offenders - Terry Thomas 2016-08-13

Sexual offending has become a mainstay item of reporting in our daily newspapers, and television news bulletins. This book offers an account of the policing of sexual offences and the difficulties that confront the police in the investigation of these intrusive crimes. It surveys the breath of sexual offences and examines the reporting of sexual crime and the attrition level that follows. It proceeds by critically assessing the efforts the police are making to overcome these difficulties and the degree to which they are making progress. The book outlines the relatively new police role of policing the convicted sex offenders themselves, who are living in the community and are subject to risk 'management' by the police and the requirements of the sex offender register held by the police. Written by a leading expert, this timely book will be of great interest to scholars of sexual offending and criminal justice.

Sex Offenders in the Community - Amanda Matravers 2013-10-18

This book explores current criminal justice responses to the management of individuals who are convicted of sexual offences. It aims to help policy-makers, practitioners and students to develop an informed position on this complex and increasingly controversial issue. Although the focus is primarily upon the UK context, contributions from North America (USA and Canada) provide an important comparative perspective.

Contemporary Sex Offender Risk Management, Volume I - Kieran McCartan 2017-12-05

This book, the first of two volumes edited by McCartan and Kemshall, focusses on perceptions of sexual offenders, and how risk is used by policy makers, stakeholders, academics and practitioners to both construct and respond to unknown and known sex offenders within the contexts of criminal justice, health and social policy. The chapters provide an oversight of contemporary policies, practices and debates within the area to help both professionals and researchers. The collection focuses on emerging areas (public health approaches, prevention, public perceptions of sexual abuse, and social constructionism), as well as more traditional topics (media, preventative and exceptional sentencing, resilience, and work force development). The authors examine public and professional engagement on sex offender management, and the changing socio-political landscape of sexual offender management. A bold and engaging volume, this edited collection will be of great importance to scholars and practitioners interested in perceptions of sexual offending.

The Registration and Monitoring of Sex

Offenders - Terry Thomas 2012-03-29

This book seeks to track the origins of sex offender registers, their purpose and the law and policy that underpins them in various parts of the world. Sex offender registers are not really registers at all but a set of 'legal requirements' that fall automatically on a person convicted or cautioned for a designated sexual offence; the term 'register' is a form of shorthand for these requirements, designed to be a contribution to greater public protection and community safety. This book provides the first serious and detailed narrative of the conception and implementation of the sex offender registers. It seeks to do so in a clear and easy-to-follow text that will be both informed and critical and will also serve as a resource book for those wanting to make further study of the process of registration and monitoring. It looks in detail at the practice of implementing registers and considers questions about their effectiveness in monitoring sex offenders and the implications of someone being on a sex offender register. The book examines the legal challenges to registers and monitoring and the position of registrants in the context of human rights and seeks to place registers and monitoring in the wider context of what is being called the surveillance society. The Registration and Monitoring of Sex Offenders will be key reading for students of criminology and criminal justice, surveillance and human rights and practitioners in criminal justice fields of policing, probation, social work, children's services, the judiciary, prison work and others.

Sex Offenders - Cathy Cobley 2005

Sex Offenders: Law, Policy and Practice is a unique and authoritative book examining sexual offending and the management of sex offenders. The complex issues inherent in dealing with sex offenders are dealt with here including the investigation of sexual offences, trial procedures, sentencing, control, risk assessment, protection of the public, treatment, housing and protection of children and adolescent offenders. Democracy and Deliberation - Cary Federman

Sex offender laws include residency restrictions, registration and notification requirements, and post-conviction civil commitment. These laws and regulations impose serious restrictions on the movements of convicted sex offenders. This is controversial because these laws and regulations occur after the sex offender has completed his time in prison. These laws and regulations are intended to have both a deterrent and therapeutic effect. Residency restrictions seek to prevent sex offenders from recommitting their crimes and civil commitment provides psychological services while incarcerated in a forensic facility. Most works on this subject are deeply critical of these laws. Cary Federman takes a more sympathetic approach to sex offender legislation. He focuses on the deliberative intentions of legislators, exploring the limits of judicial review and the rights of interested parties to influence lawmaking. Leaders of these interested parties are usually the parents of children who have been sexually violated and murdered. Critics of sex offender legislation tend to focus on the convicted parties, arguing that their rights have been violated. *Democracy and Deliberation* asserts that these laws are expressions of the deliberative intentions of lawmakers concerned about public safety—they are thus constitutional, if not always wise.

The Sex Offender Register examines the origins,

history, structure and legalities of the UK sex offender register, and explores how political and public opinion has influenced the direction the policy of registration has taken. Delving into the origins of the UK sex offender register and how the registration policy has evolved, this book provides an understanding of the register and its contribution to public protection while attempting to see the register as a policy that has grown and developed and as having an organic life of its own. The sex offender register is designed as a form of public protection rather than a punishment, requiring offenders to notify the police of their circumstances and to accept a degree of offender management from the police. The book:

Evaluation of DoD Correctional Facility Compliance with Military Sex Offender Notification Requirements - 2002

In 1994, the Congress enacted the Jacob Wetterling Crimes Against Children and Sexually Violent Offender Registration Act (the Wetterling Act) requiring certain sex offender registrations and notifications to State and local law enforcement officials in the State where the sex offender resides, is employed, carries on a vocation, or is a student. The Departments of Commerce, Justice and State, the Judiciary, and Related Agencies Appropriations Act of 1998 (CJSA) included military sex offenders under the Wetterling Act coverage and required notifications beginning 1 year after enactment. In addition, under the Victim and Witness Protection Act of 1982 (VWPA), when an offender is sentenced to confinement, the victim and certain witnesses of the crime are entitled to information concerning the confinement process and changes in confinement status. The custodial agency must provide each victim with general information regarding the corrections process, including information about work release, furlough, probation, and eligibility for each. After trial, and at the request of the victim or witness, the custodial official responsible for the actions must notify each requesting victim and witness, at the earliest possible date, of (a) the date on which the offender will be eligible for parole and any scheduled release hearing, (b) any escape, work release, furlough, or other form of release from custody, and (c) death of the offender while in custody. Objectives. Our primary objective for this evaluation was to determine whether the Department of Defense (DoD) satisfies its notification requirements for military sex offenders, including whether DoD and/or individual Service: regulatory guidance adequately address the legal requirement to notify State and local law enforcement and registration officials when a convicted military sex offender is released from confinement or is convicted but not confined, etc.

Public Opinion on the Appropriateness of Juvenile Sex Offender Registration and Notification Requirements - Jennica M. Janssen

The Sex Offender Registration and Notification Act (SORNA) was drafted with the intent to protect communities from dangerous perpetrators, but public perceptions of the appropriateness and value of juvenile sex offender registries may be more nuanced. This research explored public perceptions of juvenile sex offender registration and notification laws across the United States and the conditions under which the public (N = 1,384) believes youth who commit sex offenses should be registered as sex offenders, including the severity of the offense and the characteristics of the offending individual (i.e., age and sex). A between-subjects analysis of variance and parallel mediation analysis, conducted using SPSS and Hayes's PROCESS macro v3.5, uncovered no interactions but did reveal that the acceptability of registering the youth as a sex offender differed significantly by age of the offending youth, sex of the offending youth, and the severity of the crime. Results of the parallel mediation indicated that the perception that registering the offending youth as a sex offender keeps the community safer significantly mediated the relationship between age of the offending youth, sex of the offending youth, and offense severity, and the acceptability of registering the youth a sex offender. Additionally fear of the offending youth significantly mediated the relationship between sex of the offending youth and offense severity, and the acceptability of registering the youth a sex offender. Overall findings suggest the public may not generally agree with registering youth who commit sex offenses. Future directions and policy and practice considerations regarding the registration of youth who commit sex offenses are discussed.
