The central importance of understanding these persons, however, is that they serve a symbolic function in justifying the imprisonment of the other 99%. The insanity defense, as Stone (1975) has noted, is "the exception that proves the rule." By exculpating a relatively few people from being criminally responsible for their behavior, the law inculcates all other law violators as liable for social sanction.
