Preventing and Responding to Gender-based Violence in Middle and Low-income Countries - Sarah Bott 2005

Worldwide, patterns of violence against women differ markedly from violence against men. For example, women are more likely than men to be sexually assaulted or killed by someone they know. The United Nations has defined violence against women as "gender-based" violence, to acknowledge that such violence is rooted in gender inequality and is often tolerated and condoned by laws, institutions, and community norms. Violence against women is not only a profound violation of human rights, but also a costly impediment to a country's national development. While gender-based violence occurs in many forms throughout the life cycle, this review focuses on two of the most common types-physical intimate partner violence and sexual violence by any perpetrator. Unfortunately, the knowledge base about effective initiatives to prevent and respond to gender-based violence is relatively limited. Few approaches have been rigorously evaluated, even in high-income countries. And such evaluations involve numerous methodological challenges. Nonetheless, the authors review what is known about more and less effective-or at least promising-approaches to prevent and respond to gender-based violence. They present definitions, recent statistics, health consequences, costs, and risk factors of gender-based violence. The authors analyze good practice initiatives in the justice, health, and education sectors, as well as multisectoral approaches. For each of these sectors, they examine initiatives that have addressed laws and policies, institutional reforms, community mobilization, and individual behavior change strategies. Finally, the authors identify priorities for future research and action, including funding research on the health and socioeconomic costs of violence against women, encouraging science-based program evaluations, disseminating evaluation results across countries, promoting investment in effective prevention and treatment initiatives, and encouraging public-private partnerships.

Surviving Sexual Violence - Liz Kelly 2013-04-26

Women's awareness of the threat and reality of sexual violence is now perhaps more than ever publicly acknowledged. Yet this fact continues to be almost wholly ignored. This new study, based on in-depth interviews with 60 women, is the first to cover the experience of a range of forms of sexual violence over women's lifetimes. Family Violence in the United States - Denise A. Hines 2020-08-24

Sexual Assault - Tatjana Hörnle 2023-02-16

Sexual assault law has been undergoing significant shifts around the world. Traditional criminal laws against sexual assault had a narrow scope: they targeted rape as coerced sexual intercourse, and they defined coercion as physical violence or threats with physical violence. Modern offense descriptions are tracing a change in the logic and structure of criminal laws against sexual assault from the offenders' violence to the victims' lack of consent as the key feature of criminal wrongdoing. However, there are clear and marked differences regarding the offense descriptions in substantive criminal laws in various jurisdictions. *Sexual Assault: Law Reform in a Comparative Perspective*

provides an overview of the debates surrounding the concept and definition of sexual consent, comparing the context and content of law reform in six countries: Canada, England and Wales, Germany, Sweden, the U.S. (concentrating on the American Law Institute's Model Penal Code), and Spain. Leading scholars in the field also analyse the normative questions that arise once the notion of consent gains centre stage. The overall purpose is to assess whether the new generation of criminal prohibitions reflect coherent and convincing concepts of sexual autonomy and consent, and what could be considered the best models for future law reform.

The Work of Rape - Rana M. Jaleel 2021-08-09

In *The Work of Rape* Rana M. Jaleel argues that the redefinition of sexual violence within international law as a war crime, crime against humanity, and genocide owes a disturbing and unacknowledged debt to power and knowledge achieved from racial, imperial, and settler colonial domination. Prioritizing critiques of racial capitalism from women of color, Indigenous, queer, trans, and Global South perspectives, Jaleel reorients how violence is socially defined and distributed through legal definitions of rape. From Cold War conflicts in Latin America, the 1990s ethnic wars in Rwanda and Yugoslavia, and the War on Terror to ongoing debates about sexual assault on college campuses, Jaleel considers how legal and social iterations of rape and the terms that define it—consent, force, coercion—are unstable indexes and abstractions of social difference that mediate racial and colonial positionalities. Jaleel traces how post-Cold War orders of global security and governance simultaneously transform the meaning of sexualized violence, extend US empire, and disavow legacies of enslavement, Indigenous dispossession, and racialized violence within the United States. protected.

Regulation of Sexual Conduct in UN Peacekeeping Operations -

Olivera Simic 2012-05-25

This book critically examines the response of the United Nations (UN) to the problem of sexual exploitation in UN Peace Support Operations. It assesses the Secretary-General's Bulletin on Special Protection from Sexual Exploitation and Sexual Abuse (2003) (SGB) and its definition of sexual exploitation, which includes sexual relationships and prostitution. With reference to people affected by the policy (using the example of Bosnian women and UN peacekeepers), and taking account of both radical and 'sex positive' feminist perspectives, the book finds that the inclusion of consensual sexual relationships and prostitution in the definition of sexual exploitation is not tenable. The book argues that the SGB is overprotective, relies on negative gender and imperial stereotypes, and is out of step with international human rights norms and gender equality. It concludes that the SGB must be revised in consultation with those affected by it, namely local women and peacekeepers, and must fully respect their human rights and freedoms, particularly the right to privacy and sexuality rights.

Re-versing the Social Gaze: Sexual Violence, Law and Gender - Manasi Sinha 2013-12-09

Research Paper (postgraduate) from the year 2013 in the subject Sociology - Gender Studies, grade: A, Jawaharlal Nehru University (School of International Studies), course: Ph.D, language: English, abstract: The formation of gender identity and consequent gender differences is instilled in the social fabric, reinforced in daily life and is practiced and perpetuated through the process of socialization. This leads to asymmetry and consequent inequality which in a way sanctions male hegemony over gender hierarchy and allows for a male gaze through which women are viewed as an object of gratification; a vulnerable group; a voice less gender; and traditional care-givers. This narrow gaze vis a vis women consequently put the lives of women in jeopardy and expose them to various sexual violence and discrimination in private and public domain. However, enforcement of law has not

sufficiently reduced the crisis of sexual violence. The reason behind this being legal consciousness having a narrow value laden gaze in which sexual violence is defined through the same larger framework of patriarchal discourse which considers it to as crime only. This escapes the root cause of sexual violence and intensifies the problem of gender inequality and gender violence in society. This paper therefore, attempts to analyze the ways through which women are viewed through a social gaze which objectify them as modest, tender, and weak and thus justifies their vulnerability in public spaces. It also analyses how the legal

consciousness has been influenced by the patriarchal gender discourse and reinforces this social gaze. Therefore, this paper seeks to investigate into new ways which helps in reversing this social gaze by triggering a change in the social mindset at larger level so as to delimit the scope of this social gaze on women. This, the paper holds that the solution lies in reversing and widening the social gaze with respect to gendered space, gender role performance, and conceptual domain of sexual violence so that a woman could receive her freedom, liberty and rights not being a woman only but as an equal gender.
