The Political Activities of Detroit Clubwomen in the 1920s Jayne Morris-Crowther 2013-03-15 In the early 1900s, Detroit's clubwomen successfully lobbied for issues like creating playgrounds for children, building public baths, raising the age for child workers, and reforming the school board and city charter. But when they won the vote in 1918, Detroit's clubwomen, both black and white, were eager to incite even greater change. Nearly

15,000 mostly white clubwomen were represented by the Detroit Federation of Women's Clubs, which was formed in 1895 by the unification of the Detroit Review Club, Twentieth Century Club, Detroit Woman's Club, Woman's Historical Club, Clio Club, Wednesday History Club, Hypathia, and Zatema Club. Morris-Crowther begins by investigating the roots of the clubs in pre-suffrage Detroit and charts their growing power. In the end, Morris-Crowther shows that Detroit's clubwomen pioneered new lobbying techniques like personal interviews, and used political education in savvy ways to bring politics to the community level. A Century of Juvenile Justice Margaret K. Rosenheim 2002-03-15 Systems for Youth in Trouble Gateway to Justice Jennifer Ann Trost 2005 The Juvenile Court of Memphis, founded in 1910, directed delinquent and dependent children into a variety of private charitable organizations and public correctional facilities. Making a Modern U.S. West Sarah Deutsch 2022 To many Americans in the nineteenth and twentieth centuries, the West was simultaneously the greatest symbol of American opportunity, the greatest story of its history, and the imagined blank slate on which the country's future would be written. **Cops and Kids** David B. Wolcott 2005 Juvenile courts were established in the early twentieth century with the ideal of saving young offenders from "delinquency." Many kids, however, never made it to juvenile court. Their cases were decided by a different agency--the police. Cops and Kids analyzes how police regulated juvenile behavior in turn-of-the-century America. Focusing on Los Angeles, Chicago, and Detroit, it examines how police saw their mission, how they dealt with public

demands, and how they coped daily with kids. Whereas most scholarship in the field of delinquency has focused on progressive-era reformers who created a separate juvenile justice system, David B. While some departments embraced "child-friendly" approaches to policing, others clung to rough-and-tumble methods. By the 1920s and 1930s, many police departments developed new strategies that combined progressive initiatives with tougher law enforcement targeted specifically at growing minority populations. available to punish men who patronized prostitutes, the Committee lobbied for a change in the state's criminal law. Their proposed "Customer Amendment" united the moral Right and the feminist Left in an effort to alter and use the state's criminal law to make men moral, defend their character, and improve New York City's overall morality. Mackey's contribution to the literature is unique. Instead of looking at how vice commissions targeted female prostitutes or the commerce supporting and surrounding them, Mackey concentrates on how men were scrutinized. Book jacket.
