**Multi-Agency Public Protection Arrangements and Youth Justice** Baker, Kerry 2009-02-11  
Multi-Agency Public Protection Arrangements (MAPPA) are now one of the central features of government policy in the UK for managing the risk presented by violent and sexual offenders. Although there has been research and debate concerning the use of MAPPA with adult offenders, their application to young people has received relatively little attention until now. Multi-Agency Public Protection Arrangements & Youth Justice extends the existing literature on public protection. It provides a detailed exploration of MAPPA policy and practice in order to prompt further debate about the implications of the risk paradigm for young people and youth justice practitioners. But this response, it is argued here, has developed in a reactionary way to media and public anxiety regarding the punishment and control of sex offenders (who have abused children) and the perceived threat of such offenders in the community.
